

# **PURPOSE**

The report seeks to confirm arrangements for a family fun day event, to be held adjacent to the Horse Tram Office on the 28th January 2019.

## **RECOMMENDATION**

That the Victor Harbor Horse Tram Authority invite local radio station Fleurieu FM to undertake an outside broadcast adjacent to the Horse Tram Office on the 28<sup>th</sup> January from 11am to 3pm.

# **INFORMATION**

Those present agreed that the outside broadcast caravan and associated annexes would fit comfortably on the approach driveway to the Tram Office allowing for the walkway and ticketing stall to remain open and not interfere with ordinary tram operations.

Fleurieu FM representatives were issued with a permit form to be completed and returned to Council along with a copy of public liability insurance certification.

The radio station intends to undertake interviews of staff, volunteers and passengers about the horse tram experience with interviews broadcasted 'on-air' across the day.

A verbal request was received during the on-site meeting for representative(s) of the South Coast Camera Club to be present on the day taking images of activities for future promotional purposes by the tram.

## **RISK ASSESSMENT**

The following risks relating to this report have been identified.

**Safety & Welfare** - there is a risk of electrocution where unsatisfactory electrical cabling is used by Fleurieu FM. This risk is significantly reduced ensuring that all electrical cables are tagged and tested prior to use. This risk is rated as *low*.

**Public Relations** - there is a risk that images captured by the South Coast Camera Club are used by the authority without consent from talent. This risk is significantly reduced through the completion of talent release forms by people featured in photos captured on the day. This risk is rated as *low*.
