#### INFORMATION

#### Purpose

The purpose of this report is to provide an update from the General Manager to the Board, regarding Horse Tram operations.

#### Background

Whilst the following matters are operational and do not require endorsement by the Board, they are important in providing information to the Board around the projects that are being worked on and the day to day operations.

#### Commentary

Covid-19 has seen a lockdown which stopped operation for 3 days- luckily we were able to get back to work on the Sunday 22 Nov 2020. It was really quiet but we felt good getting the horses back to work and showing the Tram running was great for the area.

October figures are really showing how much covid has affected our takings with no interstate visitors or internationals and how going forward we need to be promoting the

Tram and encouraging people to visit our beautiful area. I will be working on ways to promote the Tram over the next couple of weeks.

# <u>Staff</u>:

Training of the new staff ready for the Christmas period is underway and progressing nicely. Staff meetings, staff information on procedures and staff inductions are occurring.

Our Christmas get together is planned for the 22 Dec 2020 at the Tram office, pizza and drinks will be provided and families are welcome.

# Horses:

Over all the horses are looking fantastic and have recently had the vet out for their annual drenching. This is a preventative measure against sand colic.

Paddock move has occurred and they are all back at Canton place enjoying the green feed and the shade.

Jay Jay and Scotty have been successfully brought back into work and all staff are getting individual training so as to drive the same way, providing consistency to the horses.

Horses have been rotated through having a break before the busy Christmas period with the Covid lockdown helping this.

# New Land at Canton place update:

I have had a meeting with Barefoot Designs in relation to a master plan of the land so as to provide a visual update to all of our long term vision for this area.

I have had Meetings with council staff regarding the new stables and the positioning on the land. Marking of the pine trees that need to be removed has happened. Surveying of the land is happening so we will have the boundary pegged and the levels done on the portion where we want to build the Stables.

Cleaning up of the site is also getting planned with the use of Depot staff and equipment to help with this process, this will be charged out to the Tram. Consideration is being given as to how to dispose of the bio-solids stock pile.

Initial costings of the Stables have come back and plans are being adjusted ready to go out to tender.

# Tram renovation update:


The tram is looking great with all the steel work striped back and the wood work all freshly vanished. The stairs were removed and sandblasted and are primed ready for painting. The paint arrives this week (26.11.20) for the rails, steel steps and timber panels, so once it's painted the tram will be put back together and will be back into operation.

This has been a long process but well worth it as it's been able to be completed during covid and has cost very little compared to quotes that were provided for it to be taken off site and completed.

# Work Health Safety update:

Skytrust is proving helpful, with more online inspections having been created, completed and instantly uploaded. All of our workplace inspections are current and up to date. Certain inspections also act as a staff cheat sheet to ensure procedures are correctly followed, and in the correct order, as they progress through the 'inspection' making for a safer process and workplace.

Due to Skytrust incident reporting is simpler and easily reviewed. The following graph demonstrates incidents reported this calendar year to date. The incidents are grouped according to their type for analysis. You will note that the column for 'near miss' incidents appears quite high. This occurs as nearly all incidents are near misses and can be represented on the graph more than once when they fall into several categories. You can see that we do not experience an excessive amount of incidents, despite working with horses and the public, which can be put down to the care and attention of staff, and our safe operating procedures which are strictly followed.



Of note, since the prototype ramps have been used on the trams, incidents where injury actually occurs have ceased, showing that the ramps are proving to be a big success. The ramps themselves have not caused a tripping hazard, which was the fear. The prototypes need some improvements, and design styles are being considered, but these modifications really are to tweak what is already working, so a big 'well done' to our Assistant Manager, Adrian.

The team are in the early stages of forming a Work Health Safety Committee. Advice has been sought to determine what an effective and practical committee might look like, and consideration is underway as to who should be on that committee. As the team already work together and consult one another regarding safety issues and the best development of safe operating procedures, we expect that an official committee will not require significant time and resources, but in fact hone down processes, increasing safety and efficiency simultaneously.
