## INFORMATION

#### Purpose

The purpose of this report is for the Authority to consider and recommend to Council to give consideration to reappointing Paul Brown, Rachel Kennedy and Nigel Catt as Independent Board Members for a third term.

## Background

The Victor Harbor Horse Tram Authority Charter sets out the requirements for a Board Member to be eligible for reappointment as follows:

- 2.9.5 A Board Member is eligible for reappointment at the expiration of a term of office except that no person shall hold office as a Board Member for more than three consecutive terms.
- 2.9.6 Prior to the conclusion of the term of office of any Board Member, a further appointment will be made by the Council.
- 2.9.7 The Council must give to the Authority a written notice of appointment of a Board Member.
- 2.9.8 Each Board Member must give to the Authority a signed written consent to act as a Board Member.

At the Ordinary Council meeting held on Monday, 23 November 2020, Council reappointed Paul Brown and Nigel Catt to the Victor Harbor Horse Tram Authority as Independent Board Members for a three-year term commencing on 1 March 2021.

At the Ordinary Council meeting held on 28 March 2022, Council reappointed Rachel Kennedy to the Victor Harbor Horse Tram Authority as an Independent Board Member for a two-year term commencing on 1 March 2022.

## Commentary

With Paul Brown, Rachel Kennedy and Nigel Catt's terms due to conclude on 1 March 2024, all three members have indicated they wish to be reappointed to the Board for a third term.

As the Board has entered an established and effective stage, it's considered it to be advantageous for the Authority to recommend to Council to consider and reappoint Paul Brown, Rachel Kennedy and Nigel Catt to the Authority Board for a third term. The advantages of reappointing all three members will ensure the Authority retains their knowledge and valuable skills.

The terms of remaining Independent Board Member, Natasha Hunt's term is due to conclude on 1 March 2025.

To ensure the Authority meets the requirements of Clause 2.9.3 of the Charter, it's recommended that Paul Brown and Nigel Catt be appointed for a three-year term, and Rachel Kennedy be appointed for a two-year term.

This will ensure that no more than two Board Members terms of office expire in the same 12-month period.

#### **INFORMATION**

#### Purpose

The purpose of this report is for the Board to consider recommending to Council the approval of the sale of two Clydesdale horses and the purchase of a foal when one becomes available.

## Background

On October 2022 Council acquired two Clydesdales, Norman and Finnis, for a total of \$11,000. The horses were purchased for the specific intention of pulling the horse tram on behalf of the Victor Harbor Horse Tram Authority. The Victor Harbor Horse Tram's primary business centres around its Clydesdales, and the continued success of the operation relies on the consistent capability of these horses to pull the tram effectively.

#### Commentary

Since commencing, the two aforementioned Clydesdales have encountered challenges in fulfilling their designated roles of pulling the horse tram, primarily due to inherent nervousness in the presence of people and when navigating the causeway. Seeking expert advice, an equine specialist was consulted who has advised that both of these horses are unlikely to overcome their innate fears, rendering them unsuitable for tram-pulling duties.

Considering these circumstances, the Authority is seeking approval to proceed with the sale of the two horses. An offer has already been received of \$12,500 per horse, and investigation reveal this is a fair and reasonable offer.

With consideration towards sustainability of quality horses, the Authority will explore the purchase of a suitable foal when one becomes available in the future. Both the Board and Council will be updated at this time.
